PRESIDENT'S ANNUAL REPORT

On behalf of the Management Committee of the Queensland Sub Districts Cricket Association Inc., I present for your consideration the Annual Report and Financial Statements covering our activities for the 2016/2017 cricket season.

Twenty-seven clubs affiliated for the season – two clubs, Everton Districts CC and Brisbane Challengers CC entering our Association for the first time.

The number of teams participating for the season in the Saturday two day competition reduced slightly – fifty nine teams nominated and played over eight grades

Our Super 20 competition, sponsored by Kookaburra Sport Pty. Ltd. saw seven teams from six clubs compete for the Andy Bichel Cup.

The season's Saturday fixtures were played with few days affected by wet weather. The weather is always of some concern when we play Semi-finals and Grand Finals on consecutive days and unfortunately the weather adversely affected most of the Grand Final matches.













































































SEASON FORMAT

The format for the season consisted of seven limited over matches and eight two day matches being scheduled.

STATISTICS

The facilities provided by Cricket Australia through the "My Cricket" programme continue to be used during the season. The input to this facility is available to all players and is particularly used in obtaining match fixtures and points in the competition table.

Clubs are becoming more cooperative in the input of match results with fewer penalties for late lodgement. Our thanks go to club administrators for their attention to this important detail.

The statistics provided by "My Cricket" were again used in determining the award winners in the various categories – teams were reminded during the season that failure by a team to input the results and scores would affect the chances of players receiving awards.

UMPIRES

Whilst the number of umpires increased slightly in the early part of the season, our numbers dropped off a little when some umpires became unavailable at various times. The Management Committee intends pursuing the task of increasing our numbers by approaching clubs who may have players retiring from playing and encouraging them to take up umpiring. We have also gained and will continue to gain experienced umpires from other organisations.

With the number of umpires available, we were in the fortunate position of having an umpire available for most matches. An umpire was always allocated to A1 games.

Our umpires are encouraged to complete the Level 2 accreditation. Our thanks to Kevin Haley for organising the allocation of umpires for each round and also to Mel Johnson for his time and efforts in preparing training sessions for our umpires.

PRESENTATION OF AWARDS

The annual function for the presentation of awards was again held at the Cricketers Club, Woolloongabba, on Saturday evening, 8th April, 2017.

Approximately 180 players and guests attended, our MC for the evening being Mark Braybrook with Bulls legend Jim Maher as our Guest Speaker.

A well supported raffle together with an auction of cricket equipment provided additional entertainment during the evening

We again thank our major sponsors for the evening – Heritage Bank Ltd, Kookaburra Sport, Keith Dudgeon Sports, Queensland Cricketers Club. Their support enables the Association to provide a quality evening at an affordable price.

FINANCE

The attached audited Financial Statements show net assets of the Association of \$161,072.12.

Being very much aware that the general cost of living continues to rise, the Management Committee made a decision at the AGM to keep the price of balls unchanged so that for the past three seasons, whilst the cost of balls to

the Association has risen, our clubs continue to benefit by paying the "old price". For the same reason, the Management Committee recommended that affiliation fees (\$220.00 per team) remain the same as for the past three seasons thereby assisting our clubs with their finances.

The support from Kookaburra Sport in sponsoring our Super20 competition is gratefully acknowledged and continues to assist clubs by reducing the cost to players in the competition.

QUEENSLAND CRICKET

Our Association records the support received from Queensland Cricket during the year, especially in providing the venue for our regular Association meetings The Directors, CEO and staff at Queensland Cricket continue to help our Association and for this we are most grateful. In particular we acknowledge the assistance by Queensland Cricket officers Michael Wright and Michael Fisher.

The contribution from Queensland Cricket relating to the financial arrangements from the former bat raffles and Gabba ground boxes is also acknowledged

CONCLUSION

Your cricket association QSDCA, continues to provide an all turf competition for over 1000 registered players. This includes our Super Twenty20 competition sponsored by our major sponsor Kookaburra Sports.

As indicated to us by Queensland Cricket on a number of occasions, there is still a decline in the number of junior cricketers transitioning to senior cricket. We are aware that many junior cricketers take up part-time work as they get older that takes up time when they would have played cricket but there are also other sports that at times draw them away from cricket. We strongly urge all cricket clubs to make contact with junior cricket clubs in their area, to encourage them to join with you in providing a pathway through senior cricket.

We also remind clubs that the Super Twenty competition was brought in to provide a different style of cricket as was requested but, the intention was always to provide cricket for those who could not play on a Saturday due to work commitments, for example. Playing for your club on the Saturday and then again on the Sunday for Super Twenty can lead to some difficulty with family time.

Clubs would be aware that the Management Committee once again did not increase affiliation fees and has held the cost of cricket balls the same for the past 3 years . This is done to assist clubs in meeting their financial obligations with costs such as wicket fees, wicket preparation etc . The finances of the Association are in my opinion well managed by the Management Committee.

Sponsors such as Kookaburra Sports; Keith Dudgeon Sports; Queensland Cricketers Club and Heritage Bank provide support to the Association and this has been of great benefit to us. We also received good financial support, as did all affiliates, from Queensland Cricket in relation to a financial share from sale of corporate boxes at The Gabba.

I acknowledge the support from members of the Management Committee in attending to the various administrative tasks required. On behalf of the Management Committee I especially want to thank our Secretary, Assistant Secretary and Treasurer.

All fixed assets are depreciated over their estimated useful lives using the straight line method of depreciation.


