PRESIDENT'S ANNUAL REPORT

On behalf of the Management Committee of the Queensland Sub Districts Cricket Association Inc., I present for your consideration the Annual Report and Financial Statements covering our activities for the 2017/2018 cricket season.

Thirty clubs affiliated for the season – Four clubs: Bethania CC, Napoleons CC, Redland Sharks Juniors CC and Skills Aviators CC entering our Association for this season – Nine clubs entered 3 teams, 10 clubs entered 2 teams and 11 clubs entered 1 team.

The number of teams participating for the season in the Saturday two day competition reduced slightly – fifty eight teams nominated and played over eight grades

A new 50 over competition played on alternate Sundays attracted 10 teams from 9 clubs. Unfortunately the Grand Final was washed out.

Our Super 20 competition, sponsored by Kookaburra Sport Pty. Ltd. saw seven teams from seven clubs compete for the Kookaburra Cup.

All matches on three days of Saturday fixtures were completely washed out- some matches in the Sunday and Super 20 competitions were also washed out during the season

GROUNDS

Thirty five grounds were utilised for fixtures throughout the season. Only twenty nine were needed for each round – not all grounds were available each round so the number of surplus grounds per round was minimal

The standard of wickets and grounds was generally very good – however some grounds suffered from lack of time in the preparation of the wickets. This is a continuing problem with time poor volunteers.

Equipment now available to clubs mainly through grants is of a reasonable standard and the Association continues to assist clubs when requested.

KOOKABURRA SUPER 20 CUP



Our Kookaburra Super 20 competition attracted seven teams in one division competing for the Kookaburra Cup.

This included three from outside of our Association. Fixtures were played on Sunday mornings and Sunday afternoons. Congratulations to Wellington Point for winning the competition with Custard CC being the runner up. This season we again provided cash prizemoney for the runner up and

competition winner.

The interest in this competition with the 20/20 format seems to be waning.

Once again, our thanks to Kookaburra Sport Pty. Ltd. for their generous sponsorship of this competition – also to the clubs who provided their grounds for the Sunday fixtures and to our growing band of umpires

SEASON FORMAT

The format for the season consisted of seven limited over matches and eight two day matches being scheduled - a total of fifteen rounds.

The format started with three limited over matches followed by four two day and three further limited over fixture matches until the Christmas break – this included two one day matches coinciding with the Ashes Test weekend. One limited over match after the break followed by four two day matches.

This provided for 23 playing days, commencing on 16th September 2017 and finishing on 3th March 2018. The semi finals and finals were then played over two days on consecutive Saturdays and Sundays.

Five grades each with eight teams competed in grades A1, B1, B2, B3, C1, with three grades A2, C2 and C3 comprising six teams – a total of 58 teams

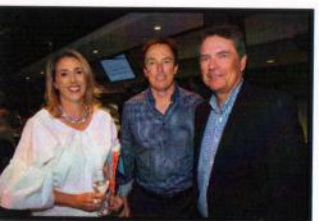

CONCLUSION

QSDCA continues to provide cricket for over 1000 players on turf wickets. Whilst we do understand that the costs in preparing turf wickets have risen and will continue to rise, feedback from players over many years has encouraged us to avoid moving away from turf wickets.

Over the past season we provided a T20 competition (sponsored by Kookaburra Sports) that achieved mixed satisfaction in results that were not helped by rain and teams needing to request moving fixtures to different dates. The new Committee will discuss this prior to next season.

We also provided a 50 overs one day competition playing on alternate Sundays which was popular but, was also affected by rain where two Sundays and the Final were washed out. The players enjoyed this competition and it will be included in the fixtures next season.

Both the T20 and the 50 overs competitions were provided to assist clubs to have an alternative for players that could not play on a Saturday due to e.g. work commitments, even though it seems there are a lot that want to play on both days.

Arising from discussions over a lengthy period with Queensland Cricket it is obvious that many junior cricketers reach a certain age where they leave the game to pursue other interests and we need all clubs to play some active part in retaining any junior cricket players that they have, to build the game in their club. We have noted that some clubs have fathers and sons playing together in a team which is a positive factor and we urge all clubs to welcome juniors into club conversations to make them a part of the club.

Our major sponsor is Kookaburra Sports and we are about to sign a further 3 years agreement with them for their valued sponsorship. They provide QSDCA with cricket balls and other equipment as part of our agreement.

The Management Committee of QSDCA has managed to keep the cost of cricket balls charged to clubs as the amount charged 4 years ago. The subsidy from QSDCA to clubs for this benefit for the past season was \$8,740 with the subsidy amount being slightly less for the previous season.

The Management Committee has, in my opinion, managed the finances of the QSDCA satisfactorily apart from the matter of Skills Aviators (a new team) who, despite regular follow ups with them that achieved promises to

STATISTICS

The facilities provided by Cricket Australia through the "My Cricket" programme continued to be used during the season. The input to this facility is available to all players and is particularly used in obtaining match fixtures and points in the competition table.

Although this system has been in use for many seasons, some clubs are very lax in recording results and other statistics within the required time frame and as a result are penalised for late lodgement.

The statistics provided by "My Cricket" were again used in determining the award winners in the various categories – teams were reminded during the season that failure by a team to input the results and scores would affect the chances of players receiving awards. Teams were reminded on a number of times throughout the season of the requirement to enter these statistics

UMPIRES

Thirty umpires were registered with the Association for this past season . Unfortunately all umpires were not available for all matches.

The Management Committee intends to continue pursuing the task of increasing our numbers by approaching clubs who may have players retiring from playing and encouraging them to take up umpiring. We have also (and will continue) to gain experienced umpires from other organisations.

An umpire was always allocated to A1 games. Umpires from QCU&SA were available at times to assist and we thank them especially for helping out in the play offs – two badged umpires were thus available for every match in the play offs.

Our umpires are encouraged to attend umpire seminars and our own umpire meetings have sessions included to improve their efficiency. Our thanks to Kevin Haley for organising the allocation of umpires for each round.



PRESENTATION OF AWARDS

The annual function for the presentation of awards was again held at the Queensland Cricketers Club, Woolloongabba, on Saturday evening, 28th April, 2018.

Approximately 170 players and guests attended, our MC for the evening being Mark Braybrook with Rodney Hogg (former South Australian and Test bowler) as our guest speaker

A well supported raffle provided additional entertainment during the evening

We again thank our major sponsors for the evening and during the past season— Kookaburra Sport, Queensland Cricketers Club, Keith Dudgeon Cricket Specialist and Queensland Cricket. Their support enables the Association to provide a quality evening at an affordable price.

FINANCE

The attached audited Financial Statements reveal the net assets of the Association amount to \$147631.15, a reduction of \$13440.97

It will be noted in the financial statements that there is a Provision for Bad/Doubtful Debts \$4534.20. This amount is still owed by one club ,despite numerous promises to pay during the season.

The Management Committee is actively pursuing payment of this debt.

Costs to clubs have been contained at previous levels – affiliation fees, umpires, balls, wicket fees – these were not increased for the season.

One matter of concern is the slow payment of accounts by numerous clubs. The executive of our clubs should ensure that their clubs are meeting their financial obligations within a reasonable time.

The support from Kookaburra Sport in sponsoring our Super20 competition is gratefully acknowledged and continues to assist clubs by reducing the cost to players in the competition.
