## **PRESIDENT'S ANNUAL REPORT**

On behalf of the Management Committee of the Queensland Sub Districts Cricket Association Inc., I present for your consideration the Annual Report and Financial Statements covering our activities for the 2018/2019 cricket season.

Twenty-five clubs affiliated with QSDCA for the Saturday season which consisted of 56 teams played over 7 Grades.

The Sunday Fifty Overs One day competition consisted of 1 division of 10 teams which included 5 new that affiliated with QSDCA for the first time.

The Sunday Fifty Overs competition was popular with the players and most fixtures were deliberately played at grounds that had canteen facilities to cover for a possible long day.

Our Kookaburra Super 20 Competition did not receive the anticipated support from clubs and consisted of 4 teams.

Next season the Management Committee will be actively promoting both the Fifty Over and Super 20 competitions where the aim will be to play all fixtures on alternate Sundays.

## STATISTICS

The "My Cricket" system provided through Queensland Cricket is used to input results of individual scores of players and full results of matches throughout the season.

It is extremely important that clubs ensure this area of cricket is always given full attention by them. Clubs are fined for not entering match results in a timely manner. Our preference is to not fine clubs but some clubs seem to ignore deadlines.

At the end of the season these statistics are used to determining the winners of some of the annual trophy awards, so entering information into My Cricket by the deadlines is important.

## UMPIRES

We had 28 qualified umpires registered to umpire in our matches this past season however there were a number of rounds where we had as little as 21 umpires available to stand in a match.

Certainly, we need more umpires and so we will be communicating with the clubs to try to talk to recently retired players about umpiring in our matches. We will endeavour to align our fixtures with those of Grade Cricket thereby creating the opportunity to call on any excess QCU&SA umpires to cover our matches.

Umpire training in the form of meetings held at Queensland Cricket will continue. On that subject, we thank retired international umpire Mel Johnson for his time and input at those training meetings.

Umpires are aware that they are observed during the cricket season in order to assist them in gaining experience on the field. We thank observers Mel Johnson, Jim Torpey and Dave Orchard for their time in observing and providing valuable feedback to the umpires on their performances.





## PRESENTATION OF AWARDS

The Annual Trophy Presentation Night and Dinner was held at the Queensland Cricketers Club, Woolloongabba on Saturday 27 April 2019. Approximately 150 players and guests attended a very successful evening. ## FINANCE

The attached audited Financial Statements reveal the net assets of the Association amount to \$134,965.48, a reduction of \$12,665.67.

It will be noted in the financial statements that there is a debtor being Alexandra Hills CC showing the amount owing of \$2330.00 at 31 May 2019. At the time of this Annual Report going to print, the debt amount has not been reduced. The last communication received in writing from the Alexandra Hills CC was by email dated 14 June 2019 advising that they were having their AGM on 26 June 2019 where a new President and Secretary would be installed on their club committee.

The email stated that we would receive a further response shortly after that date and at the time of printing of this report we have had no response.

Costs to the clubs have again been contained regarding the cost of Kookaburra cricket balls, affiliation fees, etc. This was decided to show that we are supporting clubs even though some are slow to pay invoices that are sent out to them.

### CONCLUSION

QSDCA continues to provide cricket for over 1,000 players with all matches played on turf wickets. The costs and time in the preparing of turf wickets is well known to the Management Committee. Whilst we are aware that the costs will continue to rise, regular comments from the players continue to encourage us to remain as a turf wicket competition.

Aside for our normal Saturday competition consisting of two days and one day matches, we also provide T20 and Fifty Overs One day competitions intended to be played on alternate Sundays. We see that as being supported by players and clubs to accommodate players who are not able to play on Saturdays.

Over the years we have had discussions with Queensland Cricket where it has been shown that the sport of cricket continues to lose junior cricketers around the age of 15. Some clubs in our competition have fathers and sons playing together in the lower grade teams in their club, which is seen as a positive step towards getting junior cricketers to remain in the cricket family. We urge all of our clubs to welcome junior cricketers into their club, especially those around the ages of 15 or 16 and get them involved in senior cricket.

Our major sponsor is Kookaburra Sport. Our current agreement with them is effective until 31 August 2021. We regard their sponsorship as invaluable to cricket where we are provided with cricket balls at reduced cost and cricket equipment towards the sport.



Existing QSDCA clubs would be aware that QSDCA has been subsidising the cost of balls to the club over the past years. That subsidy figure has grown to a large amount over that period of years and it is clear that the subsidy needs to be trimmed. The Management Committee is in the process of assessing the subsidy amount but, rest assured, any adjustment will be small.

The Management Committee has, in my opinion, managed the finances of QSDCA in a satisfactory manner. As at 31 May 2019 there was only one club listed as a debtor. We are of the belief that this will be resolved prior to commencement of the new season.

All fixed assets are depreciated over their estimated useful lives using the straight line method of depreciation.

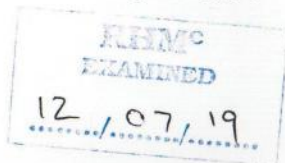
