PRESIDENT'S ANNUAL REPORT

On behalf of the Management Committee of the Queensland Sub Districts Cricket Association Inc. it is with great pleasure that I submit for your consideration the Annual Report and Financial Statements covering the activities of the QSDCA for the 2020/2021 season.

This season QSDCA provided cricket for 54 Saturday teams competing in 8 Grades, 10 teams in 2 Grades for the Sunday 50 Overs Competition and 8 teams for the Sunday T20 Competition. These teams represented 30 individual clubs and the matches were spread over 35 grounds.

This season saw the highest Grade being A1 renamed the Chatsworth Shield Competition in honour of the actual Shield that this Grade has competed for over many years. This Shield commenced in the season of 1946/1947.

Whilst the Fifty Overs Competition was well supported, the Kookaburra Super 20 (T20) did not grow as we had hoped and, perhaps, we need to promote it more.

GROUNDS

The Association used 35 different grounds throughout the season.

Two of our regular grounds at Bottomley Park, where cricket was played for some 50 years, were lost to rugby union due to issues between the lease holder Easts Rugby Union Club and Coorparoo Cricket Club. Most unfortunately the Brisbane City Council supported the lease holder in the resolution of a dispute.

Another of our clubs, West Brisbane Cricket Club, is under pressure from a lease holder (being the local soccer club) where they are being pressured to pay exorbitant fees to play at their home ground Bowman Park. West Brisbane Cricket Club have played at this ground for well over 60 years playing in the summer with soccer (mainly juniors) being played in the winter. From time to time the soccer club committee would pressure the cricket club by increasing the fees and expenses that they require from West Brisbane Cricket Club. According to recent reports it appears that the aim is to remove cricket from Bowman Park by continually increasing costs to be paid by West Brisbane Cricket Club. In a similar situation to the Bottomley Park issue, it appears that the Brisbane City Council is supporting the soccer club by giving tacit support to the increasing of fees and costs to cricket clubs.

Due to the Covid situation a number of grounds were still being used for football up until late November. As a result, we were forced to hire grounds at Marchant Park from Warehouse Cricket on at least 2 occasions. This uncertainty meant that we could only set fixtures 2 to 3 weeks in advance during that time.

Funding was sought from the QSDCA grant allocation funds by West Brisbane Cricket Club and Wellington Point Cricket club for cylinder mowers and were successful. External sourcing of funds for a new mower at Gibson Park was also successful. In general, most cricket pitches were of good quality and we thank the many volunteers involved.





Kookaburra Super 20 Cup (T20) and Mel Lowings Cup - Sunday Cricket

The Kookaburra Super 20 Cup was contested by 8 teams playing on alternate Sundays throughout the season. Brisbane Legends Cricket Club led up to the last fixture but were beaten in the Grand Final played at the Valley Cricket Club grounds by Mansfield Lions Cricket Club.

The Mel Lowings Cup Sunday 50 overs competition was contested by 10 teams split into A and B Grades. The matches were played over alternate Sundays at various grounds in Brisbane.

Playing with confidence Mansfield Lions Cricket Club won the Mel Lowings Cup A and are the proud winners of both Sunday trophies for this season.

West End Wanderers Cricket Club played very well in the B Grade Final to end up as B Grade winners of the 50 overs Competition.

The Management Committee is currently looking at including an Over 40's Veterans Competition to be played on alternate Sundays to complement these competitions.



SEASON FORMAT

Once again, we started the season with 3 rounds of one-day limited over matches, followed by 5 two-days matches, then a one-day fixture up to the two weeks Christmas Break. A one-day fixture in the New Year was followed by 4 two-days matches to round off the season. This format appears to be popular with most of the clubs.

Semi Finals over Saturday and Sunday followed with no rain interference. Unfortunately, the same could not be said about the Grand Finals where most fixtures were rain affected.

In the Grand Final for the Chatsworth Shield (A1 Grade) Rochedale South Cricket Club gallantly held off a surge from the lower placed Ashgrove Cricket Club, where the rain stopped play at the right time for the winners in what looked like an exciting match. This left Rochedale South Cricket Club as worthy winners of the Chatsworth Shield for 2020/2021. This match was live streamed through "Frogbox "and attracted 580 individual viewers.

REPRESENTATIVE MATCHES

QSDCA provides the opportunity for players to play representative cricket through our providing a team to play for the Plunkett Cup.

The Plunkett Cup Competition has been in existence for a number of years and is in a 50 Overs one-day format. Teams from Warehouse Cricket, Logan District Cricket, Ipswich Cricket Association and Toowoomba Cricket Association together with QSDCA play against each other for the Plunkett Cup. This season each team played 3 matches. QSDCA finished on equal points with Ipswich Cricket Association resulting in QSDCA playing them in the Final at Ipswich. Our team played well and won the Plunkett Cup in an exciting match.

QSDCA is indebted to the Rochedale South Cricket Club for making their facilities available for our home matches over a number of years. Special mention and sincere thanks goes to Denis Golinski for his selecting of the teams, following up on players availability and organising the team for these matches. Denis becomes and is an important part of this team.

STATISTICS - MY CRICKET

The My Cricket website through Cricket Australia is used to record our results of fixtures including players scores, ladders and umpire reports. Whilst a majority of clubs enter the match details within the required time frame, a number of clubs fail to do so. All clubs are aware of the importance of the match details being entered on time but some do not see the seriousness of it.

The Management Committee will be recommending to the new Committee that this aspect is monitored more closely and that offenders be dealt with.



UMPIRES

Our umpire numbers decreased for the 2020/2021 season and this is certainly concerning.

During the season we were assisted with up to 16 umpires from QCUSA helping out at various times, however we still could only cover about two thirds of Saturday matches. Fortunately, we were able to always provide an umpire for the Sunday fixtures.

The Management Committee has undertaken consultation with our clubs to identify club players and members who wish to become umpires in an effort to increase umpire numbers.

We are indebted to Mel Johnson for his wise counsel in conducting the umpire meeting during the season. His words of advice and tuition certainly helped to improve the standard of our umpires.

We also thank Mel Johnson and Jim Torpey for their umpire observation reports throughout the season. This assists our umpires to generally provide improved performances.

PRESENTATION OF AWARDS - 100 YEAR CELEBRATION

The Covid problem prevented us having our annual awards dinner for 2019/2020.

This year we planned and organised to have Merv Hughes as our guest speaker for our annual dinner function to be held on Saturday 19 June 2021 at the Queensland Cricketers Club. Unfortunately, Covid hit Victoria and prevented our guest attending.

MANAGEMENT COMMITTEE

The Management Committee met at least every month, if not in person, then by Zoom.

The new normal created by COVID was well handled by the Management Committee.

During the off season your Management Committee has been working with Warehouse Cricket Association and Queensland Cricket with a project to create a Community Cricket Championship competition in two grades. This will be a joint competition with the top teams in QSDCA and Warehouse competing. Sponsorship is already approved from Queensland Cricket for the supply of Kookaburra four piece balls at no cost and further outside sponsorship is being sought. This should provide high quality cricket for our teams at no extra cost than the usual fee structure.

The Management Committee has engaged the services of Michael Fisher following his departure from Queensland Cricket early in 2020. Some of the projects that the Management Committee have engaged him to do is to set up a sub-committee profile for QSDCA and to engage with our clubs to help with the roles of the various sub committees. One highlight that came out of this project is that, like many other groups, the Committee is very much overloaded with work in organising and running the Association.

Another task that Michael has been given is to pilot a bridging competition for those players leaving junior cricket and high school and not wanting to go straight into the Premier Grade scene. This competition will allow up to four senior players in each team to act as mentors. It is the intention that this competition will be played as an extra grade.

As you can see the Management committee has been very pro-active over the last 12 months.

I thank those members of the Committee and hope that other QSDCA members will look to serve of the Committee for the coming seasons.
